Briefing notes and advice to Minister or Deputy Minister that would be held, generated or prepared for Rich Coleman, Steve Carr and/or Les MacLaren regarding the delay in completing the smart meter installation project, the extension of contract terms with key suppliers/contractors, including iTron and Corix, and the decision to not install smart meters without customer consent and the decision to delay installation until customer consents. Time frame is December 1, 2012 to [January 31, 2013].
