All unpaid open/uncashed/unreconciled cheques/warrants, and incomplete or unsuccessful electronic payment attempts such as EFT, ACH, wire transfer, etc. made by the [Ministry] in payment to others; specifically records that meet the following criteria: The outstanding obligation is for an amount greater than \$5,000.00; The obligation has been outstanding for a period of 6 months or longer; The payee retains the rights to claim the funds. The date range is January 1, 2003 to December 31, 2013.

Please find enclosed a copy of the records located in response to your request. The responsive portions of these records are provided to you in their entirety. Please note some information in the records is marked 'not responsive' as it does not respond to the date range of your request.
