Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Health. You narrowed your request on April 19, 2013 through conversation and/or email with Maxine Vanzetta, Manager, Information Access Operations. Your request is for:

"The costs of the investigation into the so-called health data privacy breach that occurred in 2012; Costs should include both the salaries and benefits of the investigators and any other staff recruited to help with the investigation, and the amounts paid to both in-house and external legal counsel, including costs paid to the Vancouver law firm of Taylor, Jordan, and Chafetz. Date range is March 28, 2012 to April 13, 2013."

On May 28, 2013, the Ministry responded to your request, withholding some information in the records under ss. 14 and 19 FOIPPA.

On June 6, 2013, you further clarified your request with Information Access Operations, specifically you are seeking access to not only the costs associated with regular employees but any contracted staff involved in the investigation. As a result of this clarification, the Ministry widened their search efforts which resulted in 27 additional pages of records being provided to you.
