Alternately, a summary document which contains the name of the contractor, dollar amount of the contract, short description of services provided, and the ministry's rationale for direct awarding. Time frame is April 1, 2013 to May 31, 2013.

Please find enclosed phase 2 of your request, consisting of a summary record for the Liquor Control and Licensing Branch (LCLB). The names of individual contractors supplying services under the Minor Agents Program have been withheld pursuant to section 15 (disclosure harmful to law enforcement) of FOIPPA.
