Complete job descriptions and salary grades for Audrey Lieberman, lawyer human rights, and Catherine Hunt, Supervisor of Legal Services Group Human rights; List of all public records cases that Audrey Lieberman has worked on at the BC Human Rights Tribunal (she would have a list of her cases); Records of any complaints filed against Audrey Lieberman and misconduct with the government including poor communication skills, misconduct, and instances where she was reassigned due to public complaints.
