I am writing further to your request received by the Ministry of Justice and Attorney General (Office of the Superintendent of Motor Vehicles). Your request is for:

The total number of Immediate Roadside Prohibitions (IRPs) issued in the month of November 2013; Copies of every IRP decision from the month of November 2013 in which the prohibition was revoked.

Immediate Roadside Prohibitions (IRPs) are issued by Municipal Police or RCMP. The total number of IRPs processed by the Office of the Superintendent of Motor Vehicles (OSMV) in the month of June, 2013 is 1,536. The number of IRP reviews conducted in the same month by OSMV is 260. The total number of IRPs overturned, as represented by the enclosed records, is 49.
