I am writing further to your request received by the Ministry of Environment. You narrowed your request on April 18, 2013 through conversation and/or email with John Wilson. Your request is for:

Copies of records that pertain to a boat contaminated with quagga mussels being removed from Shuswap Lake in July 2012 as mentioned in a July 16, 2012, news release titled: BC acts swiftly to deal with invasive species threat, excluding the press release or any other material prepared for public dissemination; Records that mention how the Ministry learned of the boat entering Canada, how the boat was located in BC, how the [boat] was removed from the lake. The date range is June 1, 2012 to March 22, 2013.

Please find enclosed a copy of the records located in response to your request. Some information has been withheld pursuant to sections 13 (Policy advice or recommendations), 15 (Disclosure harmful to law enforcement), 16 (Disclosure harmful to intergovernmental relations or negotiations), and 22 (Disclosure harmful to personal privacy) of FOIPPA.
