 - → one licence w/ different terms and conditions?
- Inconsistent application of business license structure between municipalities (they use the old form of licensing ie cabaret or pub); different classifications have different hours
- VT's for servers? establishments are complaining that they pay high penalties, and expect that the servers should also be responsible for paying the fine
- Licensees want staff performance tied to Serving it Right so that it follows them = what type of employees they are.
- Inspectors can compel staff to produce Serving it Right, s.15


