Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Jobs, Tourism and Innovation.
Your request is for:

“A list consisting of the number of ipads and playbooks purchased; The individuals who have received them; The selection criteria for individuals who have received them; And the cost associated with the purchase, service and on-going costs of said ipads and playbooks.”

Please find enclosed a copy of a record that was created by the Ministry of Jobs, Tourism and Innovation in response to this FOI request. The record is provided to you in its entirety.

Please note that iPads are provided to tourism staff that travel extensively and often give presentations. The iPads are used to present tourism images, maps, and the online listings program, including how listings are featured in the ministry's travel App 'Near Me BC'. In addition, staff members use iPads to demonstrate and access the ministry image bank while meeting with editors and journalists. They are often used by the team at industry meetings, where internet access for a laptop is not reliable or available.
