Some points to be aware of:

- 1. Both an Out of Province Licence and the Client Stub/BC DL must be recorded in your stats logs when processing IRPs. We are finding many files that do not have the Out of Province DL captured because the officer has written down the BC DL number on the notice form. For our purposes we need to capture BOTH DLs.
- 2. You will now see VI files that have IRP documentation in ADP/VI. This is a change in process that Appeals Registry is now conducting. You will not need to change any of our current processes in this area. Just know that you may now see files that include IRP info with the VI. See Appeals Registry Minutes below.



RTS Errors

#### Hi Everyone,

I understand that there has been a great deal of confusion around the Stats Logs and what constitutes as an RTS error to be recorded in the Enhanced Police Training column. The role of MOC is to capture "administrative errors" on the forms submitted. We are not to evaluate the narrative or report for content. This means that we only look for blanks on the RTS. Regardless of what is written we only look for the fact that the form is complete or incomplete.

For Example: if on the RTS the officer has written "123" as the serial number for an ASD that does NOT constitute as an error. Something is written in the box and that is what we are looking for. It is not our responsibility to know that the number may be incorrect in some way it is only our responsibility to check if the section is blank or not.

The only exception to this is Line 14. If line 14 is blank then it is an error, if the number written in the blank exceeds the number of documents actually received, then it is also an error.
