Relating to a train derailment near Burnaby Lake on January 11, 2014: Any report prepared for this incident, particularly cleanup efforts and any water quality degradation that might have been documented; Relating to a ship-dock collision that occurred at the Westshore Coal Terminal on December 9, 2012 where according to media about 30 tonnes of coal spilled into the nearshore waters: Water quality monitoring data from the water quality monitoring that was conducted during the cleanup effort for this incident.
