I am writing further to your request received by the Ministry of Environment. Your request is for:

All records pertaining to communications within the Ministry of Environment and the Environmental Assessment Office, and between the Ministry of Environment/Environmental Assessment Office and the Ministry of Energy and Mines regarding proposed changes to the coal export facility owned by Lafarge on Texada Island including: Any records relating to MoE/EAO review of Lafarge application to amend existing Mines Act permit for coal storage for Texada Island; Communications on MoE/EAO providing comments to MEM on the Lafarge application and the comments themselves; Any records relating to MoE/EAO review of Lafarge application to determine if a permit is required under the Environmental Management Act. The date range is April 1, 2013 to February 11, 2014.
