### Re: Independent Interagency Review Committee

At the December 16, 2013 Regular Meeting, Delta Council unanimously endorsed the recommendations in the enclosed report on the Environmental Impact Assessment for the proposed Direct Transfer Coal Facility at Fraser Surrey Docks.

It is evident from the concerns and comments received that additional work is required to address issues and answer outstanding questions, especially as they relate to potential public health impacts associated with the proposal. For these reasons, Delta is initiating and coordinating the establishment of an independent interagency review committee. The Corporation of Delta will facilitate this committee and I am extending a personal invitation for technical staff from the Ministry of Environment to participate.

The role of this committee would include providing recommendations on the responsibility, scope and terms of reference for further studies required to address issues raised by agencies and the public. We recommend this should include, but would not be limited to, an independent comprehensive assessment of the health and environmental impacts associated with the transportation and handling of coal.

This is a multi-jurisdictional issue that demands expertise in many areas. It is essential that appropriate representatives are at the table and that they are in an environment that fosters the free flow of information. It is our hope that the contribution of expertise from your Ministry to this committee and the collaborative work of its members will produce meaningful, practical recommendations towards further assessment and understanding of the impacts of transportation and handling of coal in our communities.

Dear Mayor Jackson and Council:

Thank you for your letter of December 17, 2013, regarding the establishment of an Independent Interagency Review Committee for the transportation and handling of coal. I apologize for the delay in responding.

The Fraser Surrey Docks coal terminal expansion proposal is located on federal land, overseen by Port Metro Vancouver. The Ministry's evaluation on the proposal is limited to examining potential discharges to the environment proximate to the docks. Stormwater on the site is treated and discharged into Surrey / Metro Vancouver sewer systems and the Ministry is satisfied there are no discharges associated with stormwater to the Fraser River from this project.

Air emissions, such as dust from coal transfer, fall under Metro Vancouver's delegated responsibility under the *Environmental Management Act*. The Ministry continues to monitor this file but has no regulatory authority over the project.

As you have noted, the transportation and handling of coal is a multi-jurisdictional issue. Standards for the safe operation of railways and rail equipment fall under the jurisdiction of Transport Canada. The federal government does not regulate for coal dust emissions resulting from the transportation of coal by rail. The federal government does regulate the transportation of some commodities, under the *Transportation of Dangerous Goods Act*; however, coal has not been classified as a dangerous good under this Act.

The Ministry has an air quality monitoring program that takes air quality readings at stations throughout the province outside Metro Vancouver. Metro Vancouver also has an extensive air quality monitoring program. The Ministry and Metro Vancouver stations do not monitor for coal dust, but do monitor for finer particulates considered to cause respiratory problems, such as smoke from fires and diesel exhaust.

Staff from the ministry's Victoria office have volunteered to attend the review committee's meetings by telepresence in an observational capacity to determine what, if any, role the Ministry might play. As the Ministry does not have regulatory authority over the Fraser Surrey Docks proposal or the Metro Vancouver airshed, we are limited in our ability to provide recommendations or act in a lead role. The Ministry recognizes the concern in your community around coal and is interested in the committee's work to better understand and define these concerns.

Hi Bernadette, Ryan and Carlene,

Attached please find our current IN regarding concerns from various groups over the possible health and environmental effects of handling/transporting coal at the proposed Fraser Surrey Docks (FSD) facility. This IN is often changed to reflect the ongoing opposition to the expanded coal handling terminal. I'm hopeful it will help give you an overview of the issue.

The latest development for MOTI is a letter (attached pdf) from Delta Mayor Lois Jackson to Minister Stone, advising that Delta Council has unanimously endorsed the recommendations in the Environmental Impact Assessment (EIA) for the proposed facility at FSD and to provide a copy of that report to the minister, as recommended. She advises that Delta is initiating and coordinating the establishment of an independent interagency review committee (MOE and HLTH have been asked to participate but interestingly, not MOTI) whose role would include providing recommendations on the scope, responsibility and terms of reference for further studies required to address concerns/issues raised by other agencies and the public through the EIA process, with the request that Port Metro not give this project a green light until this work has been done.

My questions to you are:

- 1. Have your Ministries received similar letters from Delta Mayor Lois Jackson?
- 2. If so, are your Ministries preparing to respond?
- 3. Who in your program area is working on this file? (I am asking so my program area contact, Michael Crawford, can get in touch with them as needed to provide a coordinated front moving forward). This issue has been discussed at the executive level between all ministries before Christmas. My understanding is they'll be meeting again soon to strategize on how to handle this one. I will let you know when this could happen again.

MOTI intends to respond to Delta's letter next week. I will loop all of you in on the response as soon as I can.
