I am writing further to your request received by the Ministry of Justice. You narrowed your request on June 2, 2014. Your request is for:

Relating to the Ministry of Children and Family Development's recent decision to close the Victoria Youth Custody Centre (VYC Centre), communications between Deputy Minister Mark Sieben, Assistant Deputy Minister Alison Bond and Executive Director Lenora Angel regarding the decision to close the facility, including briefing notes and consultations. You agreed to exclude submissions and/or cabinet committee meetings as you were advised they would be withheld in their entirety pursuant to section 12 (cabinet confidences). However we did agree to provide you with the number of submissions and cabinet meetings. New time frame of November 2013 to May 1, 2014.
