MSD-2014-00360:

Any and all contracts including service agreements and service contracts related to Integrated Case Management over \$10,000 including how the contract was awarded. Alternately, a summary document which contains the name of the contractor and any affiliates, the dollar amount of the contract, a comprehensive description of the services provided, and description on how the contract was awarded. Time frame is April 1, 2012 to May 14, 2014.
