Deputy Minister to the Premier, Cabinet Secretary and Head of the Public Service

John Dyble was appointed Deputy Minister to the Premier and Cabinet Secretary on March 14, 2011. In this position he is also the Head of the Public Service, the largest employer in the province with over 30,000 employees and more than 200 distinct fields of occupation. Previously, Mr. Dyble was the Deputy Minister of Health Services.

Before joining the British Columbia Public Service, he worked in consulting engineering at Sandwell Swan Wooster. As part of his consulting engineering work, he spent time in a number of countries, including Mozambique, Bangladesh, Cameroon and Turkey.

In 1989, he joined the Ministry of Regional and Economic Development. In 1993, he was appointed Regional Director of the Vancouver Island/South Coast Region in the Ministry of Small Business, Tourism and Culture. John became the Assistant Deputy Minister of Planning and Major Projects at the Ministry of Transportation and Highways in 1997 and was subsequently appointed Assistant Deputy Minister of Highways in 2001. John was appointed Deputy Minister of Transportation in 2005 and served in that capacity until January 2009 when he was appointed Deputy Minister of Forests and Range. John was appointed Deputy Minister of Health Services in June 2009.

John has a Bachelor of Applied Science in Civil Engineering (1982) and is a Registered Professional Engineer. He also has a Masters of Business Administration. Both of his degrees are from the University of British Columbia.
