This is in reply to your February 13, 2012 webmail in which you ask why a correctional centre is being built when it is your understanding that the Nanaimo Correctional Centre at Brannen Lake is only half full.

The following three points address your query:

- The Nanaimo Correctional Centre (NCC) is currently operating at 95% utilization, well above half full. It has often operated above 100%.
- NCC is a medium security centre for sentenced inmates classified to this level of security. The correctional centre announced for the Okanagan will be a secure centre that will house both remanded and sentenced inmates.
- The NCC is not in a location that is able to serve the needs for a correctional centre in the Okanagan, now or in the future. Currently the Kamloops Regional Correctional Centre is the only provincial correctional facility serving Okanagan communities. It is overcrowded and additional capacity is needed. The Okanagan Correctional Centre will also relieve overburdened police lockups in the Okanagan and will provide better access by lawyers, family and support agencies.
