I am writing further to your request received by the Ministry of Forests, Lands and Natural Resource Operations. We have completed processing your request.

All records for the McCuddy Reservoir Dam from Bruce O'Neill (Senior Dam Safety Engineer), including photos, construction records, notes, inspection reports and any records pertaining to the safety of the dam. Date range is January 1, 1970 to May 6, 2013.
