During the writ period, the non-partisan and professional public service enters into what is considered "caretaker" mode.

In terms of government communications, our proactive activities are restricted to items that are statutory (required by law), necessary health and safety information, or related to services that remain available to the public during the writ period. As in past election campaigns, staff at Government Communications and Public Engagement will continue to respond to media inquiries but are exercising caution to avoid circumstances where statements could in any way be perceived as partisan. On April 12, we posted information to this effect on the home page of the BC Newsroom (www.newsroom.gov.bc.ca http://www.newsroom.gov.bc.ca).

Program areas that have statutory requirements during the writ period will have sought their own advice – for example, both legal advice and counsel from Elections BC – on appropriate conduct during the writ period.

Tuesday, April 16 will mark the start of the provincial election or Writ period. As a result, government will be observing Elections BC rules and restrict public communication and our web and social media presence to items which are

statutory in nature, necessary health and safety information, or related to services that remain available to the public during the writ period.

Since public health and safety is the utmost of importance, communications materials, websites and social media accounts required for their communication will remain active. Most other websites and accounts will appear "frozen". But, we're still available to answer questions about available services! As well, in the event of a public health and safety issue of any kind (natural disaster, health issues such as a pandemic flu, etc), government will immediately be at work to respond and to keep the public well informed.

Guidelines for Government advertising, communications, Internet and social media during the election period (updates in blue)

The election period

An election usually lasts 51 days. It begins when the writ of election is issued. A writ is a formal order signed by the Chief Electoral Officer and the Lieutenant Governor calling for an election to be held. In a general election, a writ is issued for every electoral district in the province. The day the writs are issued is called Day 0.

The election period ends on Day 50 when the writs are returned to the Chief Electoral Officer.

General Voting Day, the day when most people vote, falls on Day 28. After voting ends on General Voting Day, most of the ballots are counted and preliminary results are released. The final results are usually released by Day 43, after all the absentee votes are counted and the preliminary results are confirmed.

Between Day 43 and Day 50 Elections BC closes down its temporary offices and helps conduct any judicial recounts that may be needed.

The writs are issued Tuesday, April 16th.

Elections BC has provided guidelines regarding the regulation of government communications during an election. During the election campaign (April 16 – May 15), advertising, communications, Internet and social media are limited to health and safety of the public and answering questions from the public related to services (this does not include statutory advertising, please see below). All other communications requests will be considered on a case by case basis. While there are strict rules governing government communications during the campaign period, direction for the period immediately following the election – i.e. for Day 29 to Day 50 – will be clarified after election day.

Elections BC recognizes that government will continue to inform the public of available services during the campaign period. However, government communicators are reminded that there are perception issues regarding what does and does not constitute election advertising in addition to a public expectation that Elections BC will respond to complaints regarding advertising during the campaign period.



Government Communications and Public Engagement Communications Support Services

Advertising

Advertising is any paid or in-kind informational activity including print, radio, TV, outdoor displays or Internet. All advertising falls into one of two categories: "Informational" or "Statutory":

- "Informational" advertising provides information about government policies, operations, programs and issues which are not required by statute, regulation or policy. "Informational" advertising is not permitted during the campaign period.
- "Statutory" advertising is required by statute, regulation or policy. "Statutory" advertising is permitted during the above period.

Distribution of advertising materials during the writ period must be approved by the ministry GCPE Communications Director and Executive Director, Marketing and Communications Support Services.

Communications Materials

Communications materials are also divided into two categories, "Informational" and "Statutory." "Informational" materials and services are any activities or products that are used to inform audiences, or raise awareness about a particular program, service, policy or issue. These may include (but are not limited to) publications, presentations, brochures, posters, videos, pins, buttons, coffee mugs, flags, signs or services, including those provided by a media relations or public relations contractor such as strategic planning, media relations, graphic design, video production, etc.

Generally, distribution of "Informational" material is not permitted during the campaign period.

Distribution of communications materials during the writ period must be approved by the ministry GCPE Communications Director.

Internet

Any new Internet websites /web-pages should either go live **before 1:30 April 15**, or go into production the day after the transition period. The only exception for website changes is for fixing spelling errors or correcting information.

Any other postings to Internet websites during the writ period must be approved by the ministry GCPE Communications Director.

Social Media

If your ministry has a program area that uses social media we ask that you communicate these guidelines to them and ask them to refrain from posting content that maybe perceived as promotional for government.

During the writ period, all other program area postings to social media must be approved by the ministry GCPE Communications Director.

Please note: websites and social media accounts considered critical to public health and safety will continue during the writ period. These accounts are: Drive BC and Emergency Info (includes Emergency Prep account). All other accounts will be considered on a case by case basis via the ministry Communications Director.

Advertising related:

What is Election advertising?

The transmission to the public by any means, during the campaign period, of an advertising message that promotes or opposes, directly or indirectly, a registered political party or the election of a candidate, including an advertising message that **takes a position** on an issue with which a registered political party or candidate is associated. (Elections BC)

What about logo recognition with partner programs?

The BCID may be used to recognize a partnership with the Print for programs run by third parties during the writ period provided that the logo recognition is **required to fulfill a contractual agreement that was in place prior to the writ period**. Logos affiliated with government programs may not be used. Logo recognition with the BCID is permitted where other partners/sponsors are recognized, such as signage or collateral material, however the BCID should not be included in any advertising activities.

Can I research a new project?

Research conducted on behalf of the Province, or in partnership with the Province, is not permitted during the writ period.

What about international marketing? I'm scheduled to attend a trade event in Asia, can I bring my usual promotional materials? What should I avoid?

Advertising during the writ period is not permitted. However, due to the timing and logistics of these events I advise that you connect with me for review on a case by case basis.

Communications materials related:

What about news releases, Information Bulletins, photos and video?

Communications is suspended during the writ period. There will be no news releases, IBs etc. Any photos or video collected cannot be distributed. The only exception is for messaging related to the health and safety of the public.

Internet/web related:

My ministry would like to have a button added to our ministry homepage- can we do that? Unfortunately, no. Websites are "frozen" during the writ period. The only exception is for spelling errors and fixing incorrect information.

A program area in my ministry would like to launch a new section on the website. It's a great project with positive benefits to the community and won't be controversial. Can we quietly launch it?

Same as above. Even if a project is very worthy and has good ramifications for BC, it can't be launched via on a website or using communications materials, social media or advertising until after the writ period.

Social media related:

A program area in my ministry has a social media account with a campaign for engagement that ends May 1. They've been promoting that date and the engagement quite heavily and they feel it will impact their effectiveness. Can they continue to communicate using social media?

Unfortunately, no. In a case like this, we advise telling program areas to have a plan in place to let their followers know that the writ period is coming up and they will be unavailable to communicate at that time. However, if they receive a direct question during that time (e.g. dollar amount, request for help/services) they are able to respond. In all other instances, they are asked to refrain from using social media to promote an idea/issue/engagement etc.

What happens if there is an emergency or natural disaster?

The only exception for use of social media during the writ period is for public health and safety. For that reason, DriveBC and EmergencyinfoBC and EmergencyPrepBC will remain active. If a natural disaster or emergency situation were to occur, BCGovNews and the above mentioned social media accounts will actively respond. Other government social media accounts assist by re-tweeting the emergency related information only.



Last week, at a panel discussion about the film Hope is not a Plan, Dr. Tim Stainton, director of the UBC School of Social Work endorsed the film maker's call for the shut down of almost all institutions and nursing homes currently housing the mentally and physically handicapped. He said that "all institutions engender abuse, and the risk of abuse for disabled residents of institutions was higher that average. He called for higher levels of funding for CLBC to allow it to provide the supportive living situations in the community that he sees as optimum for people living with disabilities.

Can I get a comment either from the minister or from you on these observations?

I'm guessing you are well aware of this, but other reporters are asking for a bit more information on the current drug review process... I can't remember if I sent this to you in the past, so to make sure you have it too, there is a guide on our website that walks through the three phases that drugs go through before they are approved in BC: http://www.health.gov.bc.ca/pharmacare/outgoing/drugrevproc.pdf

- The first step is a Health Canada review which ensures a drug is safe;
- The second step is a Common Drug Review this means that if a manufacturer wants provincial drug plans to cover their drug, they send a submission to the Common Drug Review (CDR), which is a national review process. It is managed by the Canadian Agency for Drugs and Technologies in Health (CADTH).
- The third step is a BC PharmaCare review PharmaCare carries out its own review before making a decision. This review builds on the work done by Health Canada and the CDR process and makes sure the decision will be right for B.C. it does not repeat work done by the CDR.

Other reporters have also asked us for previous press releases about drug review processes, and government did issue one in January 2011, which I have attached here for background:

As for your specific question, I can't provide comment as it is a political announcement, and we are in writ period and our investigation continues – but I can confirm that in September 2012 we announced that we had temporarily suspended a number of contracts related to our investigation... and there hasn't been any additional contracts suspended since then. We have not confirmed which contracts have been suspended and we still cannot confirm this information. Other than that and what we've said in the past, can't say much more at this time.

Hi Julia,

Please accept the following statement from the Ministry of Health of BC on the College of Physicians and Surgeons of B.C.'s request around patient complaints. Please note that since we are in a provincial election period – the comment is from the Ministry – not the Minister. Thanks.

Under BC's legislation, the college inquiry committee is responsible for reviewing and investigating complaints from the public about individual practitioners. The inquiry committee has authority to dismiss a complaint as being trivial, frivolous, vexatious or made in bad faith. The college board may authorize the college registrar to exercise this authority (which the College of Physicians and Surgeons of BC board has done in the case of its registrar), subject to oversight of the inquiry committee.

Inquiry committee/registrar decisions to dismiss a complaint as being trivial, frivolous, vexatious or made in bad faith are subject to review by the Health Professions Review Board (HPRB). In making and reviewing such decisions, both the inquiry committee and the HPRB must act within the bounds of applicable administrative law as set by the courts.

Reporter is working on a story about B.C.'s jury system. She's spoken with a couple who have been in Canada for about 17 years. The husband has been called for jury duty four times since becoming Canadian but doesn't feel confident enough to be a juror. Each time, he has had to go to court to ask to be dismissed but would rather write a letter requesting exemption.

- 4. Other than age and language, what are the other reasons people request exemptions? What are the most common reasons?

Approved Response: (sent April 15)

"I recognize that British Columbians who make themselves available for jury selection often have to make personal and professional sacrifices to fulfill their civic duty. It's also important to know that individual names are chosen randomly from the B.C. voter's list and the system of jury selection allows for exemptions in some cases, including instances where language is a barrier.

Individuals who are limited in their ability to speak English may request an exemption on a case-by-case basis. In B.C. an average of three per cent of the jurors summoned request to be excused for the reason of a limited ability to speak English. This compares to 15 to 20 per cent who asked to be exempted for being 65 years of age or over.

I can't speak to this specific instance, but I can say that as part of the random selection of jury selection, it is unusual, even rare, for someone to be randomly selected four times and I thank the individual for attending to their civic duty."

I just found out about 30 minutes ago that the BC Environmental Assessment Office (http://www.eao.gov.bc.ca/) is observing Elections BC rules during the writ period - this is crazy and bizarre.

Here is what they say on the front page of their website:

Public Communication During the Provincial Election

Tuesday, April 16 marks the start of the provincial election or writ period. As a result, the government will be observing Elections BC < http://www.elections.bc.ca/ rules and restricting public communication and our web and social media presence to items that are statutory in nature, necessary health and safety information or related to services that remain available to the public during the writ period.

While the work of the Environmental Assessment Office will continue during the writ period, we will not be posting new information on our website. The information that is currently posted will remain and we are still available to answer questions. If you have a question, please contact us by e-mail at eaoinfo@gov.bc.ca. We will be happy to respond. The full implications of this are not fully understood but it is extremely surprising, and concerning, that a public body with the government would be restricting information they are providing to the public.

Specifically, what does this mean for the Raven Coal Mine public process on the Island. It is Torrance's understanding that the final application for the Raven Coal Mine will be going public in the first week of May - this still needs to be confirmed.

I think this is an extremely significant development, especially if other public bodies or ministries follow suit. Surely the Election BC rules for third party advertising doesn't apply to government bodies relaying information to the public on industrial proposals.

Torrance and I are in a meeting at 11:30 but will be checking our emails frequently and can definitely step out to talk to you if you wanted to chat.

Hi David,

Because we are in a provincial election period, we are exercising caution in responding to questions – we provide strictly factual answers but cannot express opinions on behalf of government. (For more fulsome answers, you could connect with Dallas Smith, if you haven't already.) Hope this is helpful.

Q - The band claims that aboriginal consent was excluded from the agreement, against their wishes. Is this the case? Why?

A – The Nanwakolas strategic engagement agreement (SEA) establishes protocols and procedures that both the Nanwakolas First Nations and BC agree meet joint responsibilities for consultation, as defined in Section 35 of the Canadian constitution. That is the purpose of the agreement. It results in efficiencies and more effective engagement for both parties.

Q - The band also criticized the province assuming "ownership" over forest resources, by collecting stumpage from Western Forest products. Is this the case?

A - In British Columbia, 94 per cent of the land is considered Crown land and the Province manages it on behalf of all taxpayers. All forest companies that operate on Crown land pay stumpage fees to the Province for the trees they cut down.

Q - Does the government consider this a setback to its record signing modern treaties?

A – The SEA is not a treaty. Kwakiutl has a Douglas Treaty, and is not currently involved in negotiations under the modern BC treaty process.

1. When was the genesis of the LNG Initiative(s)?

On February 3, 2012, the Government of B.C. released its <u>LNG Strategy</u> alongside a <u>plan for the province's natural gas sector</u>. These sector strategies were built on the foundation of the BC Jobs Plan, which outlined governments plan to strengthen the export potential of the province's natural resources, with a formal commitment to have LNG facilities built by 2020 to create long-term prosperity.

A <u>one-year update</u> was released in February 2013, showcasing the progress made since the release of the LNG Strategy. The opportunity is emerging quickly and government is focused on making sure it happens. The benefits are substantial, including plans for a BC Prosperity Fund.

In addition to the list above, the following announcements have also revealed preliminary plans to build a LNG project:

- AltaGas signed an agreement with Idemitsu Kosan of Japan to pursue LNG.
- The <u>Nexen/Inpex partnership</u> announced a plan to build an LNG export facility last year. These companies submitted an Expression of Interest to move forward with an LNG project on provincial Crown land. Their submission was one of 4 eligible Expressions of Interest received by government. These submissions are under review now, but represent the preliminary stages of one or more new LNG projects. More details about the Expression of Interest result can be found <u>here</u>.

3. What, specifically, is the province doing to attract more sustainable investment in LNG terminals and pipelines?

Creating the foundation for a competitive LNG industry, and raising the profile of B.C.'s potential, is a primary focus of governments work to increase investment and project plans.

In March, we hosted Canada's first international LNG conference. Over 500 people attended the two-day "Fuelling the Future" conference to discuss B.C.'s LNG future. First Nations leaders, representatives from 25 B.C. communities, federal and provincial government officials, academics, and 192 companies spanning eight countries participated.

The conference profiled B.C.'s advantages for the LNG industry including access to Asian markets, a competitive tax environment, regulatory certainty and a history of safe, responsible natural gas development that makes the province a reliable place to invest and conduct business.

Investments in B.C.'s LNG potential has been evident since the release of the provinces LNG Strategy in Feb 2012. Attached to this email is a factsheet on LNG related investments as of February 2013.

4. What role is the province taking as concerns the various demands from First Nations and environmental groups in regard to LNG terminals?

The Province and LNG proponents have been working closely with First Nations in the Kitimat and Prince Rupert areas. First Nations are benefiting from the growth of B.C.'s natural gas as business partners in LNG development.

Most recently, at the LNG conference reference in answer #3, the Government of B.C. signed an Economic Partnership Agreement with 15 First Nations to secure economic opportunities for 15 First Nations along the Pacific Trails Pipeline route which will support the Kitimat LNG project. Attached is a news release providing more details about the agreement signed.

The Government of British Columbia intends to advance potential economic agreements with First Nations along other pipeline routes that support LNG projects and as these projects proceed to final investment decisions.

As LNG develops, the goal is to maximize the use of clean energy where technically feasible and to meet our climate targets. Ultimately; industry will decide what energy source they will use to power their LNG operations. If natural gas is used, industry will be subject to B.C.'s revenue-neutral carbon tax. Further greenhouse gas mitigation measures, such as carbon offsets and capture and storage, are also being explored by the Province.

5. What steps is the province taking to improve core infrastructure in and around Kitimat, B.C.?

The province is leading the development of an industrial land use plan for the Douglas Channel in Kitimat in collaboration with the District of Kitimat, Haisla Nation, and LNG and industrial interests. The plan is focused on defining the optimal alignment infrastructure to support safe and efficient operations for both existing and future planned industrial initiatives.

As mentioned in answer #3, government is focused on creating a competitive climate for LNG development and investment.

Referring to events at the LNG Conference once more, the B.C. government is rolling out new installment of the province's Infrastructure Royalty Credit Program with \$120 million in credits to facilitate new roads and pipeline projects. This program supports growth and prospects in natural gas, including B.C.'s emerging LNG industry, by expediting core infrastructure development. A news release providing more detail about the latest program is attached.

Thank you for your inquiry about the release you received about BC Safety Authority's recognition of training programs related to limited scope electrical worker certification.

BC Safety Authority is a public service entity. As a safety regulator, we are an independent, self-funded organization mandated to oversee the safe installation and operation of technical systems and equipment. In everything we do we aim to serve the best interests of safety. BC Safety Authority continues to work with industry stakeholders on the recognition of a training program that allows limited scope electrical work to be performed on specific equipment (e.g., biomedical systems, electrical components, and fire protection systems). After the initial review of an application by the Applied Science Technologists and Technicians of BC (ASTTBC), the Provincial Safety Manager was

satisfied that all electrical safety aspects of this limited scope work would be sufficiently covered and approval was granted subject to some conditions. BCSA will not recognize these training credentials until all conditions have been satisfied.

Here are the answers to your questions:

Q: by offering a certification that is less than the Red Seal standard, safety is being put at risk

A: Safety is our primary concern and consideration in reviewing any application for program recognition. Decisions regarding the merits of an application must always be based on considerations related to safety. The ASTTBC program supports national safety standards by requiring that the individuals who have been performing this limited electrical work for many years confirm they have received proper training for that scope of work. Recognition of these training programs will improve safety, not lessen it.

Q: why this change is being made and if this is work that was being done by Red Seal certified electricians previously
A: Recognition of these specific training programs does not interfere in any way with the ability of other
qualified workers to perform the same work, such as electrical workers under the Red Seal Trades
program. The Safety Standards Act requires that BC Safety Authority review all applications for
recognition of training programs. All organizations and agencies have equal opportunity to develop
training programs and submit applications for recognition. BC Safety Authority fully supports and relies on
Red Seal Trades programs in all regulated technologies as a critical component of the technical safety
system.

Regarding your email below, can you please confirm that the River Forecast Centre can continue to undertake the following during the April 14th - June 5th period as per our usual business as it relates to the freshet (spring snowmelt), potential for flooding and public safety:

- 1. Post the May 1st, May 15th and June 1st Snow Bulletins to the RFC website and distribute the Bulletins through our normal email distribution list (goes internally and externally). These are not normally reviewed by GCPE prior to posting as they are strictly technical documents.
- 2. Post any flood forecast advisories, watches or warnings to the RFC website and distribute them through our normal email distribution list (internal & external) as may be required based on the judgement of the flood forecast hydrologists. These are not normally reviewed by GCPE prior to posting as they are strictly technical documents.
- 3. Post to the RFC website and email snowpack and/or streamflow commentary's as required to inform internal and external stakeholders of specific conditions to be aware of that do not require advisories. These are not normally reviewed by GCPE prior to posting as they are strictly technical documents.
- 4. Update data sources and any other aspect of the RFC website relevant to keeping streamflow and flood risk information current on the website. These are not normally reviewed by GCPE prior to posting as they are strictly technical documents.
- 5. Respond to media regarding the status of snowpacks, steamflows, weather conditions and the risk for flooding. While most media comes through GCPE, occasionally Dave Campbell will get a call directly from the media and if a routine query, he responds directly then lets GCPE (Brennan) know that the call occurred. Can this continue during the writ period?

Advertising:

Statutory only.
