In 2009, then-commissioner David Loukidelis's annual report said: "It is certainly important that government not move forward with any legislated changes in this area unless and until there has been a full public consultation in the form of a position paper published by the government, followed by meaningful, extensive stakeholder consultations."

I support British Columbians right to privacy whether regarding smart meters or other data. I support those concerned with Bill 3.
