Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Finance. Your request is for:

"Any Ministry documents that indicate the last time the Gentax, TACS, and FAST computer systems were upgraded; The names of any other computer systems that were used in the administration of the provincial sales tax (PST) and the dates those systems were last updated."

In response to your above request for information, the Ministry has advised of the following:

- The PST was administered using the Taxpayer Administration Compliance & Services (TACS) system.
- TACS was built using a computer off the shelf (COTS) package called GenTax developed by FAST Enterprises.
- TACS was implemented on GenTax Version 1 in 1999/2000.
- Version 2 upgrade was completed March 2003.
- Version 3 upgrade was completed December 2005.
- Microsoft stopped supporting the underlying technology of Version 3 since April 2008.

- The ministry has maintained version 3 over the years to ensure it remained effective.
- GenTax is currently on Version 8 there have been significant technology advancements, new product features including electronic service capabilities.
- The ministry is re-implementing the PST using Version 8 in order to minimize operational risks, reduce support costs and transform service delivery (eServices and self-service) within the restricted time frame.
- Once the PST is established, we will migrate administration of other taxes into the updated system.

Your file is now closed.
