A Special Events Permit issued by the Ministry of Transportation is only valid for highways under its jurisdiction. Generally, this includes all roads outside city or municipal boundaries, and some of the major highways through cities or municipalities. In addition to applying for and receiving the Ministry's permit, the applicant must follow the permitting requirements of each city or municipality the Event will impact.

A copy of your application and its attachments will be provided to the policing authorities for their review and comment. The plans submitted must provide the Ministry, Municipal authorities and the R.C.M.P. and/or Municipal Police with the confidence that due consideration has been given to the needs of the motoring public, and the safety of the public and Event participants.

For all Events, a fluorescent safety vest is recommended to be worn by all persons near traffic. At minimum, all participants shall be required to wear highly visible clothing. Special Events occurring outside the daylight hours will require special consideration.

Insurance and Indemnification:

The applicant shall:

At his own expense, carry and maintain liability insurance against third party claims arising from Special Events, with inclusive limits of not less than two million dollars for bodily injury, including death and property damage;

Be solely responsible for all damages arising out of the Special Event activities;

Indemnify and save harmless Her Majesty the Queen in right of the Province of British Columbia as represented by the Minister of Transportation together with the employees, agents, and servants of the Minister, from and against all claims and demands, loss or damages in respect thereof. The maximum deductible shall be no greater than \$5,000.

The name of the insured shall include "Her Majesty the Queen in right of the Province of British Columbia as represented by the Minister of Transportation together with the employees, agents, and servants of the Minister."

The applicant shall return to the Ministry, a signed copy of the provided Certificate of Insurance (form H-111), supplied by the insurer showing that the insurance requirements have been met.

HER MAJESTY THE QUEEN IN RIGHT OF THE PROVINCE OF BRITISH COLUMBIA, as represented by the
Minister of Transportation and Infrastructure

Skeena District - 4825 Keith Avenue, Terrace, BC V8G K7

(the "Province")

AND:

Queen Charlotte Islands Hospital Day Foundation, Box 9, Queen Charlotte, BC V0T 1S0

(the "Permittee")

WHEREAS:

- A. The Province has use of highway right of way, pursuant to the *Transportation Act*, the *Industrial Roads Act*, the *Motor Vehicle Act* and the *Nisga'a Final Agreement Act*.
- B. The Permittee has requested that the Province issue a permit, pursuant to the Province's authority, for the use of highway right of way in the location and for the purpose(s) hereinafter set out.
- C. The Province is prepared to issue such a permit to the Permittee on certain terms and conditions.

ACCORDINGLY, the Province hereby grants to the Permittee a permit (this "Permit") for the use of highway right of way in the location described in section 1 (the "Permit Area"), on the following terms and conditions:

1. This Permit is issued for the use of the Permit Area by the Permittee for the following purpose(s):
106th Annual Hospital Day Parade at Oceanview Drive starting from 3rd Avenue to Bay Street on June 21st, Saturday, 2013 from 10 am to 11 am.
2. The Province will designate an official (the "Designated Ministry Official") who will act as the Province's agent in the administration of this Permit in the manner hereinafter set out.
3. The Permittee may enter the Permit Area for the period beginning the 21st day of June, 2014, and ending the 21st day of June, 2014 inclusive (the "Term").
4. This Permit will expire on the last day of the Term, or on such earlier date of termination as is provided for in this Permit.
5. The Term of this Permit may be extended past the expiration date, provided that the Province, in its sole discretion, has agreed with the Permittee with respect to the length of the extension and such extension is issued in writing prior to the expiration of the Permit.
6. The Permittee must observe, abide by and comply with all laws, bylaws, orders, directions, ordinances and regulations of any competent governmental authority in any way affecting the Permit Area including, without limitation, the safety of the individual persons involved and the public at large and, at all times, the Permittee must safeguard the travelling public.
7. Except as specifically provided for in this Permit, the Permittee must, at all times, keep the Permit Area open to traffic and, when necessary, the Permittee must ensure that the roadway is completely restored for traffic as soon as possible.


8. The Permittee must keep the Permit Area in a safe, clean and sanitary condition satisfactory to the Province and, at the request of the Designated Ministry Official, make the Permit Area safe, clean and sanitary.
9. The Permittee must not bring on to the Permit Area, or cause or permit any part of the Permit Area to be used for the storage or disposal of, any hazardous, toxic, dangerous or potentially dangerous, wastes, materials or substances capable of causing contamination to air, land or water.
10. The Permittee must not construct, erect or place any buildings, structures or other improvements on, or otherwise deface, the Permit Area unless specifically stated in this Permit.
11. On the expiration or earlier termination of this Permit, the Permittee will:
 - a. peaceably quit and deliver possession, custody and control of the Permit Area; and
 - b. remove all buildings, machinery, equipment and any other apparatus, and all improvements to, or things on, the Permit Area, at its own expense, as the Designated Ministry Official may direct;
 and, to the extent necessary, this provision will survive the expiration or earlier termination of this Permit.
12. The Permittee must obtain, and maintain in force and effect during the Term, insurance in form, content and amounts acceptable to the Province, as required by the Designated Ministry Official.
13. Prior to the issuance of this Permit by the Province, the Permittee must deliver to the Designated Ministry Official evidence of the required insurance coverage by way of the completed Ministry of Transportation and Infrastructure Certificate of Insurance (Form H0111), as attached to this Permit, duly executed by the authorized representative of the insurer. For Automobile Liability insurance ONLY, evidence may be provided either by a Ministry of Transportation and Infrastructure Certificate of Insurance OR a duly executed I.C.B.C. APV47 or APV250L form. Should any insurance policies expire during the term of the Permit, then evidence of renewal prior to the expiry date of the policy(s) must be provided. All insurance must be as required by the Designated Ministry Official.
14. As a condition of this Permit, the Permittee indemnifies and saves harmless the Province and its employees, servants, contractors and agents against any and all losses, claims, damages, actions, costs and expenses including, but not limited to, fees of solicitors and other professional advisors, made against or incurred, suffered or sustained by the Province (whether before or after the expiration or earlier termination of this Permit), arising out of or in connection with:
 - a. any breach, violation or nonperformance of any condition or term in this Permit by the Permittee; or
 - b. any personal injury, death or property damage occurring on the Permit Area or happening by virtue of the Permittee's possession, control and/or custody of the Permit Area,
 and this indemnity will survive the expiration or earlier termination of this Permit.
15. In the event that the Permittee, in the reasonable opinion of the Designated Ministry Official:
 - a. fails to make diligent use of the Permit Area for the purpose(s) permitted herein,
 - b. fails to observe or perform any of the terms, conditions and provisions contained herein, or
 - c. misrepresented or withheld any fact material to granting the Permittee the use of the Permit Area,
 the Province may, in its sole discretion, cancel this Permit, such termination to be effective immediately upon notification of the Permittee, and the rights herein granted with respect to the Permit Area will be deemed to be null and void as against the Permittee.
16. In the event that the Permittee commits an act of bankruptcy, becomes insolvent or is petitioned into bankruptcy or voluntarily enters into an arrangement with its creditors, this Permit will be deemed to be cancelled as of the date of the act.
17. The Permittee must not at any time before or during the Term of this Permit assign this Permit for all or any part of the Permit Area or the rights hereunder in any manner whatsoever without the prior written consent of the Province.
18. This Permit will be governed by and construed in accordance with the laws of the Province of British Columbia.
19. No term or condition of this Permit will be considered to have been waived unless the waiver is in writing, and a waiver of a breach of a term or condition of this Permit will not be construed as, or constitute a waiver of, any further or other breach of the same or any other term or condition of this Permit, and a consent or approval to any act requiring consent or approval will not waive or render unnecessary the requirement to obtain consent or approval to any subsequent same or similar act.

20. No remedy conferred upon or reserved to the Province under this Permit is exclusive of any other remedy in this Permit or provided by law, but that remedy will be in addition to any other remedy existing or available to the Province pursuant to this Permit or then existing at law, in equity or by statute.
21. If any section of this Permit or any part of a section is found to be illegal or unenforceable, that part or section, as the case may be, will be considered separate and severable and the remaining parts or sections, as the case may be, will not be affected thereby and will be enforceable to the fullest extent permitted by law.
22. A reference in this Permit to a statute means a statute of the Province of British Columbia unless otherwise stated and includes every amendment to it, every regulation made under it, and any enactment passed in substitution thereof or replacement thereof.
23. As a condition of this Permit, the Permittee unconditionally agrees with the Province that the Permittee is the prime contractor, as described in section 118 of the *Workers Compensation Act*, for the purposes of the work described by this Permit, at the work location described in this Permit, and that the Permittee will observe and perform all of the duties and obligations which fall to be discharged by the prime contractor pursuant to the *Workers Compensation Act* and the *Occupational Health and Safety Regulation*.
24. The Permittee is advised and acknowledges that the following hazards may be present at the work location and need to be considered in coordinating site safety: overhead hazards, particularly electrical or telecommunications lines; buried utilities, particularly electrical, telecommunication and gas lines; traffic, danger trees, falling rocks, and sharp or infectious litter.
25. *The requirements of the local police authority and other applicable local and municipal authorities must be complied with. Local businesses and residents affected by the EVENT must be notified and any objections must be worked out prior to the day of the EVENT*
26. *This permit does not relieve the applicant of any obligation with regard to adherence to the Motor Vehicle Act or any other Act or Regulation with respect to the Event*
27. *Marshals must be equipped with WorkSafe BC approved high visibility apparel.*
28. *Licensee is responsible for any additional traffic control requirements, if deemed necessary, by either the local police authority, Ministry, or Ministry representative, in order to maintain the safety of the travelling public using the highway. Implementation of any additional requirements shall be made without delay.*
29. *On site contact name and number must be provided to the Ministry or Ministry representative.*
30. *All emergency services, bus lines etc. are advised of said event.*
31. *APPLICANT is responsible to ensure that all WorkSafe BC regulations are adhered to.*
32. *The MUNICIPALITY is in agreement with all the arrangements.*
33. *APPLICANT is responsible for the clean-up and removal of all litter and debris resulting from the EVENT.*
34. *License area must be returned to its original condition or better.*
35. *The Permittee shall, at his cost, supply, erect, and maintain standard traffic control devices in accordance with the Ministry of Transportation and Infrastructure Traffic Control Manual for Works on Roadways and WCB Regulation, Part 18.*
36. *The British Columbia Ministry of Transportation and Infrastructure will not assume any responsibility or liability for any accident or injury that may occur as a result of this EVENT*
37. *The Permittee shall have 'No Parking' signs along a short portion of the Oceanview Drive near the Bay Street Road area to allow a safe flow of traffic upon set up and completion of the Hospital Day Parade. If additional 'No Parking' signs are required please contact the maintenance contractor O'Brien Road & Bridge office at 250-557-4282, to make arrangements with them.*
38. *The Permittee shall ensure the signs and barriers are removed promptly at the end of the parade.*
