Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Health. Your request is for:

"The costs of the investigation into the so-called health data privacy breach that occurred in 2012; Costs should include both the salaries and benefits of the investigators and any other staff recruited to help with the investigation, and the amounts paid to both in-house and external legal counsel, including costs paid to the Vancouver law firm of Taylor, Jordan, and Chafetz. Date range is March 28, 2012 to April 13, 2013."

On May 28, 2013, the Ministry responded to your request, withholding some information in the records under sections 14 (legal advice) and 19 (disclosure harmful to individual or personal safety) of FOIPPA.

On June 6, 2013, you further clarified your request with Information Access Operations; specifically, you were seeking access to not only the costs associated with regular employees but any contracted staff involved in the investigation. As a result of this clarification, the Ministry widened their search efforts which resulted in 27 additional pages of records being provided to you on June 26, 2013 with some of the information being withheld under sections 13 (Policy advice or recommendations), 15 (Disclosure harmful to law enforcement), and 19 (Disclosure harmful to individual or public safety), and 22 (disclosure harmful to personal privacy).

As a result of that review, the Ministry released information previously withheld under sections 13 (Policy advice or recommendations), 15 (Disclosure harmful to law enforcement), and 19 (Disclosure harmful to individual or public safety). The Ministry continued to withhold information under sections 14 (legal advice) and 22 (disclosure harmful to personal privacy).

On December 3, 2015, the OIPC issued Order F15-64 identifying information to be released that was previously withheld under section 14 (legal advice). However, some additional information continues to be withheld under section 14 (legal advice).

Please be advised that the Office of the Ombudsperson is currently conducting a review related to the Ministry of Health investigation.
