Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Environment. Your request is for:

Data submitted in monthly effluent monitoring reports in 2013 by the facility known as Neucel Specialty Cellulose, Port Alice Mill, operating in Port Alice BC: The daily values (Kg/d) and concentrations (mg/l) of the regulated substances known as biochemical oxygen demand (BOD), Total Suspended Solids (TSS) and Adsorbable Organic Halide (AOX), along with the values of any limits set by the province for these parameters and concentrations of any chlorinated dioxin and furan compounds measured during the period. The possible permit number may be 1240. Date range is January 1, 2013 to December 31, 2013.

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety. Additionally, the Ministry wishes to advise you that Environment Canada may also hold records related to the subject matter of this request.
