Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Finance. Your request is for:

Data from the Gaming Policy and Enforcement Branch regarding all incidents of violation of Section 89 of the Gaming Control Act Prohibition - unauthorized gaming by minors including dates, times, names and locations of companies and workers found in violation, and the fines, sanctions, and penalties assessed; The Gaming Information and Services Occurrence Search forms with the results of keyword searches for false ID, underage, selling, minor, youth, impersonation, project 19, child, and unattended. Date range is November 30, 2011 to June 10, 2013

Section 6(2) of the *Freedom of Information and Protection of Privacy Act* (FoIPPA), establishes that a public body has a duty to create a record from existing machine readable records if it can do so using normal computer hardware, software and technical expertise, and the creation of the record would not unreasonably interfere with the operations of the public body. The public body is not required to create a new record in cases where new computer software or hardware would be needed to create the record, where staff do not have the technical expertise required or where the task would unreasonably interfere with its operations. **In deciding whether creating the record would unreasonably interfere with its operations, the public body assesses the time and resources which would be required to create the record and the impact which this use of resources would have on its day-to-day activities. Concerning your FOI request, the more specific information relative to individual violations is not available off the Gaming Policy and Enforcement Branch's Gaming Occurrence Search (GOS) database. The physical files would have to be pulled and reviewed in order to determine whether or not they are responsive. In the spirit of section 6 of FoIPPA, the public body has made the effort to put into a spreadsheet format a list of files relative to service providers suspected of selling lottery products to minors. Creation of the attached spreadsheet took approximately five hours.

There were files that the program area was able to identify as fitting the noted violation categories in your request and which they believe **may** be responsive. They cannot say definitively whether or not any of these files will be within the scope of your request.
