Further to my letter regarding the Confederation of North, Central American and Caribbean Association Football (CONCACAF) Women's 2012 Olympic Soccer Qualification Tournament, I write to advise you of, and request your support for, an extraordinary sport hosting opportunity for the Province of British Columbia. As it has been shared in detail with your ministerial staff team, The Canadian Soccer Association is bidding to host the FIFA Women's World Cup 2015™.

On the heels of hosting a record-breaking FIFA tournament in 2007, Canada wants to invite the world back for the premier women's football event in 2015. Having had the privilege to contribute to that success through strong provincial government support for the two host sites − Victoria and Burnaby − in 2007, the 2015 FIFA Women's World Cup™ now presents a wonderful opportunity for the Province to extend the legacy of the Vancouver 2010 Winter Olympics and Paralympics, and the CONCACAF Women's 2012 Olympic Soccer Qualification Tournament, while also leveraging the infrastructure investments already in place.

In 2007, Canada hosted a record-setting FIFA U-20 World Cup, attracting close to 1.2 million spectators to 52 matches and generating an estimated \$259 million in economic activity. It delivered an excellent return for the government at the federal, provincial and municipal levels, supporting more than \$43 million in taxes at the three levels. The purpose of this correspondence is to request \$2.75 million in matching funds from the Government of British Columbia to host the FIFA Women's World Cup 2015™. If Canada is successful in winning the bid, the FIFA U-20 Women's World Cup 2014 will also be awarded to Canada as a test event. This smaller scale competition features 16 teams. Logistically, it may not be necessary for every city that is bidding for the FIFA Women's World Cup 2015™ to host this competition. The breakdown of our funding request would be such that if British Columbia is not selected as a host city for the FIFA U-20 Women's World Cup 2014, the commitment would be for only \$2M for the marquee event of the FIFA Women's World Cup 2015™.

We have already had discussions with the City of Vancouver with respect to its contribution of either \$400,000 or the equivalent of value-in-kind services, which will include all security costs and city service expenses. Here again, this would be reduced should Vancouver not be a host for the FIFA U-20 Women's World Cup 2014.

An event of this global scale needs strong partners, which is why it is our desire to collaborate with the Ministry of Community, Sport and Cultural Development to build together on many of the points highlighted in previous correspondence. Of course, a unique feature of this hosting opportunity is that British Columbia could conceivably welcome the international soccer community three times in a four year span, with the already secured CONCACAF Women's 2012 Olympic Soccer Qualification Tournament in Vancouver, plus the potential hosting of the FIFA U-20 Women's World Cup in 2014, which is inextricably linked to the FIFA Women's World Cup 2015™ as the marquee event.

Unfortunately, the timelines on our bid to secure this event are dictated by FIFA and are very tight in turn around. The CSA committed to bidding for the event on 26 November 2010 with a requirement that the guarantees, funding, and the complete technical package be committed by the end of January 2011 with a presentation to FIFA, after its evaluation of the bid, during the first week of March 2011. We have been received extremely positively by the Federal Government and have already met twice with Minister Lunn who has committed his support to the process. We hope to be in a position to make a formal announcement of the Federal Government support in the near future.

Should we be successful in being awarded the FIFA Women's World Cup 2015™, British Columbia and Vancouver would be linked to a completely national event that will be promoted from coast to coast. Exposure for the Province will be high, with world media attention focused on this premier women's event. The cities and Provinces will be afforded prominent coverage nationally and internationally by FIFA on FIFA.com, as the international soccer delivery platform, and through other broadcast opportunities.

Please let me know if you wish to have any further information on this event, either by correspondence or in person, to provide you with the reassurance that government investment in the provincial bid for the FIFA Women's World Cup 2015™ stands to reap great economic and health benefits for British Columbians both now and for years to come.


