Please note some information in the records is marked 'not responsive' as it does not respond to the wording of your request. Your file is now closed.

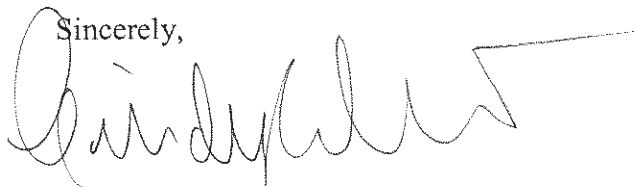
