Re: Request for Access to Records

I am writing further to your request received by the Ministry of Forests, Lands and Natural Resource Operations. Your request is for:

A copy of the Charges sent to Compliance and Enforcement, from DFO indicating the charges to be brought vs. McBride Community Forest Corporation for destruction of fish habitat CP993, Block 9, Robson Valley TSA; Relating to McBride Community Forest : A copy of any correspondence or information passed on through phone calls between FPB Auditors and the Ministry, specific to the Investigations re harvesting along the Fraser River and McKale Creek; Any documentation confirming Forest Practices Board Auditors were made aware by Ministry officials that the Ministry's Investigation of Block 9 was a joint effort with DFO, in determining that charges for destruction of fish habitat along the Fraser River, confirming also FRPA non-compliance.
