*Regarding Order in Council 185 and 186 approved on April 11, 2014 amending BC's Reviewable Projects regulation: All records relating to communication including calendar records, emails and other correspondence between Ministry of Forests, Lands and Natural Resources, Ministry of Environment, Environmental Assessment Office, Ministry of Natural Gas Development, Office of the Premier, Government Communications and Public Engagement and Ministry of Aboriginal Relations and Reconciliation with the Canadian Association of Petroleum Producers that relate to the amendment of the regulation that culminated in the issuance of OIC 185 or OIC 200 including records relating to communications between CAPP and any of the aforementioned Ministry's Ministerial offices; All background materials, briefing materials and decision notes prepared for Minister Thompson, Minister Polak, Minister Coleman, Minister Rustad, Premier Clark, or any of their respective Deputy Ministers or ADMs that relate to OICs 185, 186, 200 and 201, and/or to the negative public response to OICs 185 and 186 including any materials prepared by the Government Communications and Public Engagement Branch.
