Background / Context:

A key pillar of the Jobs Plan is the opening and expansion of markets for BC goods and services, particularly in Asia, and the attraction of investment to grow BC's priority sectors. As one of the world's fastest-growing markets, India offers tremendous opportunity for B.C.

As Asia's fourth largest economy, India is one of the fastest growing markets in the world. Indian firms have quickly become major international investors. India is also a consistent source of international students for BC's education system.



Background

In 2011 Premier Clark on her trade mission to India announced BC's intention to host the 2013 International Indian Film Academy Awards (IIFA). The IIFA's owner's (Wizcraft) proposal requested \$15 million support from the Province.

In May 2012, BC submitted a bid of s. 12 to Wizcraft, who rejected the bid. Wizcraft has not shown any willingness to alter its original proposal, s. 12

In June 2012, the Times Group (Times), the largest mass media company in India, approached the Province with a proposal for Vancouver to be the host for the <u>first</u> Times of India Film Awards (TOIFA), a new Indian film awards created by Times. The awards will celebrate Indian films and music and will be based on on-line voting from global Indian. Ministry of Jobs, Tourism, and Skills Training has engaged in several rounds of discussions with Times.
