REVIEW DECISION Immediate Roadside Prohibition ("IRP") No

Introduction

On November 18, 2011, a peace officer served you with a Notice of Driving Prohibition. You applied to the Superintendent of Motor Vehicles for a review of your driving prohibition and I am delegated the authority to conduct this review.

Section 215.5(1) of the *Motor Vehicle Act* (the "Act") requires me to confirm your prohibition, along with the corresponding monetary penalty and vehicle impoundment, if I am satisfied that you were a driver within the meaning of section 215.41(1) of the Act, that you failed or refused to comply with a demand made under the *Criminal Code* to provide a sample of breath for analysis by means of an approved screening device ("ASD"), and that you did not have a reasonable excuse for failing or refusing to comply with a demand.

I must revoke your driving prohibition if I am satisfied that you were not a driver within the meaning of section 215.41(1), that you did not fail or refuse to comply with a demand, or that you had a reasonable excuse for failing or refusing to comply. If I revoke your prohibition, I must also cancel the monetary penalty for which you would otherwise be liable under section 215.44(1), and revoke the corresponding vehicle impoundment.

In reaching my decision on this review, I must consider all relevant information provided to me.

Issues

There are three issues in this review:

- 1. Were you a driver within the meaning of section 215.41(1) of the Act?
- 2. If so, did you fail or refuse to comply with a demand?
- 3. If so, did you have a reasonable excuse?

As it is determinative of this matter, I will only consider the second issue.

Did you fail or refuse to comply with a demand?

Based on the evidence before me, I find that the officer did not make a valid ASD demand. As such, I am satisfied that you did not fail or refuse to comply with a demand.

Decision

I therefore revoke your driving prohibition and monetary penalty, as required by s. 215.5(4) of the Act. The vehicle impoundment is also revoked. The Superintendent of Motor Vehicles will pay towing and storage costs from November 18, 2011, up to and including December 21, 2011. Original receipts and invoices with proof of payment must be attached. You must also enclose a copy of this letter to ensure the correct charges are refunded to you.

Decision

As a result of my findings, I revoke your driving prohibition, monetary penalty, and vehicle impoundment, as required by s. 215.5(4) of the Act.

You may resume driving after you have obtained a driver's licence from the Insurance Corporation of British Columbia. If you hold an Enhanced Driver's Licence, you must make an appointment to reapply for that licence.

Please note that this decision does not change any other prohibitions from driving or licensing requirements.

If you have not already done so, you may go directly to the location where your vehicle is impounded for the immediate release of your vehicle. The Superintendent of Motor Vehicles will pay towing and storage costs up to and including June 25, 2013. You are responsible for any storage costs beyond that date. You should know that if the vehicle is not reclaimed, the impound lot may apply to the Superintendent of Motor Vehicles to dispose of the vehicle.

Upon receipt of your proof of payment, the Superintendent of Motor Vehicles will pay towing and storage costs up to and including the date your vehicle was eligible for release. **Original receipts and invoices with proof of payment must be attached.** You must also enclose a copy of this letter to ensure the correct charges are refunded to you.

Facts, Evidence and Analysis

There is one issue determinative of my decision in this review.

Were you a driver within the meaning of section 215.41(1) of the Act?

The evidence before me is undisputed that you were at a campsite, located in the driver's seat of a vehicle when the officer arrived. The officer indicated that after he issued the prohibition and the vehicle impounded, you stayed at the scene as you were camping there. Your evidence, corroborated by the evidence of two others who were present at the relevant time, is that you were charging your cell phones, did not intend to be driving that evening and that you did not need to leave the campsite for any reason until the following day.

Having reviewed the evidence before me, I find there was no realistic risk that you would have driven while it was dangerous to do so. I am satisfied that you were not a driver within the meaning of section 215.41(1) of the Act on May 19, 2013 at 01:47 hours, as the investigating officer reported.

Having made this finding, I do not need to consider other issues in this review.

Decision

I therefore revoke your driving prohibition and monetary penalty as required by s. 215.5(4) of the Act. As a result, the prohibition has been removed from your driving record and you may resume driving once you have obtained a driver's licence.

Despite your submission that the validity of the demand is an issue in this review, I conclude that it is not. Section 215.5(4) of the Act requires me to revoke a driving prohibition if I am not satisfied of any of the specific grounds set out in that section. The validity of the demand is not a stated ground in section 215.5(4) of the Act, meaning that it is not a ground of review. Therefore, it is not an issue that I am by statute permitted to consider in this review.

You point out that Officer Jones did not identify himself until requested to do so. There is no requirement in the Act for an officer to identify him or herself during the course of an impaired driving investigation.

You submit that Officer Jones was belligerent in nature with your wife, s.22 I acknowledge your submission; however, I do not have authority under the Act to consider the process by which an officer conducts an investigation. I note that s.22 has submitted a complaint to the Commission for Public Complaints Against the RCMP.

You point out your concern about a potential breach of privacy. Officer Jones provided the vehicle impoundment paperwork to your wife as registered owner without first verifying her identification. I note that Section 215.4(4) of the Act says that if a motor vehicle is impounded, the peace officer must take all reasonable steps to notify the owner of the motor vehicle. Preliminary Matters

You applied for this review by checking three grounds listed on the application form; however, not all of these grounds are applicable to your situation, because of the reason for which you were prohibited. For your benefit, I have considered all grounds that apply in your case.

At the beginning of the hearing your lawyer, Robert Gunnell, confirmed that he had received all of the disclosure documents before me. I proceeded with the review based on that confirmation.

Your lawyer argued that the disclosure documents are not before me, because the *jurat* on the Report to Superintendent (the "RTS") was not properly sworn or solemnly affirmed. I note that

I am confident that Constable Garcia, the investigating officer in this matter, signed the RTS, thereby executing the *jurat*. Further, I find it reasonable to conclude on a balance of probabilities that the second signature is that of the commissioner for taking affidavits, but that it is in the wrong spot on the *jurat*. The *jurat* is not the oath; it is just a certificate that the oath has been administered. An irregularly completed *jurat* does not mean the oath was not properly administered. The placement of two signatures on the document leads me to conclude that it is more likely than not that the RTS was properly sworn or solemnly affirmed.

Mr. Gunnell referred me to the *Murray* decision to support his argument that the RTS is not properly before me, however, the circumstances of this situation are more similar to those in *Tanner v. British Columbia (Superintendent of Motor Vehicles)*, 2012 BCSC 2037. Consequently, I reject Mr. Gunnell's argument in this regard.

Issues

The following are the issues in this review:

- Were you a driver within the meaning of section 215.41(1) of the Act?
- Did you fail or refuse to comply with an ASD demand?
- If you failed or refused to comply with the demand, did you have a reasonable excuse?

Facts, Evidence and Analysis

Having reviewed the submissions of Constable Garcia and your lawyer, I find there is one determinative issue in this review.

Were you a driver within the meaning of section 215.41(1) of the Act?

In the Report to Superintendent (the "RTS"), Constable Garcia indicated that he witnessed you driving or in care or control of the vehicle on June 7, 2013, at 2145 hours. The officer's evidence, including the complainant's report, indicates that you were in the driver's seat and were engaged in some use of the vehicle or its fittings or equipment. You were witnessed trying to start the vehicle, and the officer's evidence is that you were extremely intoxicated. The complainant reported that you had trouble getting into the vehicle, so it is reasonable to infer that you may have had trouble starting the vehicle, as well. Based on the evidence that was before the police, I find that your acts involved a risk of danger of setting the vehicle in motion.

However, based on all of the evidence submitted by your lawyer on your behalf, I find that you did not intend to set the vehicle in motion. Further, I find on a balance of probabilities that you would not have changed your mind in this regard. I am satisfied that you were not a driver within the meaning of section 215.41(1) of the Act. Having made this finding, I do not need to consider other issues.

Decision

As a result of my findings, I revoke your driving prohibition, monetary penalty, and vehicle impoundment, as required by s. 215.5(4) of the Act.
