The Memorandum of Understanding between UBC and the Ministry of Health that relates to post-graduate training of medical residents; and The funding letter. Any policy papers, directives, and any other documentation created in the last 5 years that documents considerations and concerns relating to creating more residency positions in BC at this time or in the future. Documents that set out the number of residency positions currently filled by residents who have had their positions purchased on their behalf referring to VISA residents.
