Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Children and Family Development (MCFD). Your request is for:

- 1) The number of MCFD staff who have been on travel status for more than a year;
- 2) An update on the progress to date of the net hiring relating to the \$12 million action plan announced on July 19, 2012, in which the ministry stated that it is actively recruiting up to 150 new auxiliary staff positions
- 3) and a listing by classification and geographic location of the positions filled under the initiative.

The Ministry wished to advise you that portions one and two of your request asks for information rather than records and are addressed below.

Regarding part one of your request, the Ministry advises that per government's Core Policy and Procedures Manual (see link) http://www.fin.gov.bc.ca/ocg/fmb/manuals/CPM/10 Travel.htm), "travel status" means travelling more than 32 kilometres from an employee's usual work place or normal point of assembly, but does not include staff who are temporarily re-assigned or on filed status or on board and lodging status. The Ministry further advises that while some of their social workers log a high number of kilometres over a year, their travel is not every single day and, as such, it does not have any staff that have been on travel status for a year or more.

Regarding part two of your request the Ministry advises that as of November 19, 2012, 105 new staff members have been hired to assist frontline social workers with training coverage and ICM documentation. The hiring process is ongoing.
