Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Education. Your request as revised on May 29, 2013, is for:

- **Copies of the Final Statistical Reports and details of receipts and expenditures submitted to the ministry by the contract recipient as required in the Schedule A of the contracts C13/2431, C12/3300 and C13/2256 as follows:**
 - **C13/2431, Appendix 1: The recipient will submit to the Province, on or before March 31, 2013, a Final Statistical Report for statistics from September 1, 2012 to March 31, 2013, along with a detail of receipt and expenditure of the Financial Contribution;**
 - **C12/3300: The recipient will submit to the Province, on or before March 31, 2012, a Final Statistical Report for statistics from April 1, 2011 to March 31, 2012, along with a detail of receipt and expenditure of the Financial Contribution; and**
 - **C13/2256: The recipient will submit to the Province, on or before August 31, 2012, a Final Statistical Report for statistics from April 1, 2011 to August 31, 2012, along with a detail of receipt and expenditure of the Financial Contribution.**

Please find enclosed a copy of the records located in response to your request. These records have been provided to you in their entirety. Your file is now closed.

The ministry has informed that:

- The Province has at no time requested the Virtual School Society or School District 73 Business Company (SD73BC) to supply detailed receipts and expenditure. Please note that C13/2431, C12/3300, and C13/2256 are Transfers Under Agreement (TUA), which is a grant – there are no “contract recipients” associated with these TsUA;
- Regarding C13/2431, Appendix 1: the Final Statistical Report has not yet been submitted by the SD73BC as the business company completes its financial auditing on a July fiscal cycle; and
- Regarding C13/2256: the Final Statistical Report has not yet been submitted by the Virtual School Society.

These records will be published on the B.C. Government's Open Information website a minimum of 72 hours after it is released electronically or a minimum of five business days after it has been released by mail in hardcopy.
