Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Technology, Innovation and Citizens' Services. Your request is for:

Amount paid for security guards services excluding the sheriffs at the Court House in Victoria and the companies paid for these services for 2010, 2011, and 2012; names of all security companies which applied for the security service contract for the Court House in Victoria since they began and a list of who the contract has been awarded to for each competition.

Integrated Workplace Solutions (IWS) branch has provided the following information in response to your request:

From a ministry perspective, SSBC IWS contracts with Brookfield Johnson Controls Workplace Solutions Inc (WSI) to deliver property management services on behalf of the Province of BC to owned, leased and managed buildings. WSI delivers services through in house staff or subcontracts to vendors. WSI has subcontracted with Paladin Security Group to provide security services at the Victoria Courthouse at 850 Burdett, Victoria, BC.

In response to the FOI request, SSBC - IWS paid WSI for security services in 2010, 2011, 2012 (Paladin has been the subcontractor during this time):

In 2003/2004, a formal procurement process for property management services, which included security services, was conducted by the Ministry. I've attached the Fairness Advisor's report on the procurement process and communiqué sent out to media outlets. The proponents responding to the RFP were: Brookfield Lepage Johnson Controls, SNC-Lavalin, Atco, O & Y CB Bentall, Trammell Crow. WSI was the successful proponent and was awarded a 5 year contract with 2 options to renew for a maximum 5 year periods. The contract was amended in 2009 and again in 2013. We are currently in the final term of the contract which will expire in 2019.

In addition, please find enclosed a copy of the report and communiqué referenced above. These records are provided to you in their entirety. Your file is now closed.

These records will be published on the BC Government's Open Information website a minimum of 72 hours after it is released electronically or a minimum of five business days after it has been released by mail in hardcopy.
