"In Excel spreadsheet format: The Census -- Daily Youth Count reports for the last three months plus the current month as per the policy and procedure manual for the Maples Adolescent Treatment Centre; Without any personal identifiers admissions, definite transfers from another unit, temporary transfers from another unit, return from elopement or AWOL, return from visit leave, return from a hospital, return from a Youth Custody Centre and discharges, transfers from unit to another unit, eloped or AWOL, returns from visit, hospital, etc.; Placed on visit leave from elopement/AWOL, deceased. Date range is February 11, 2013 to June 11, 2013."
