Re: Request for Access to Records *Freedom of Information and Protection of Privacy Act (FOIPPA)*

I am writing further to your request received by the Ministry of Education. Your request is for:

"The Ministry of Education contracted Value Management to conduct a value analysis service regarding school construction unit rates. The contract was awarded in December 1, 2011, to be completed in March 2012. I would like a copy of that report."

Please find enclosed a copy of the records located in response to your request. They include the recommendations that Value Management Inc. has submitted to the ministry in March 2011. These records have been provided to you in their entirety. Please note that some information in the records is marked 'not responsive' as it does not respond to the wording and/or the date range of your request.

The ministry has also informed that no report was created or will be created under the contract with Value Management Inc. for the school unit rates analyses. As Value Management Inc. is an ongoing contractor of the ministry, the value analysis work on school unit rates was continued in the 2010/2011 fiscal year pending the allocation of funding for this project in the following fiscal year, 2011/2012. This explains why the recommendations were submitted to the ministry in March 2011 and the contract was accounted for in the next fiscal year. Your file is now closed.
