**Re: Request for Access to Records**  
***Freedom of Information and Protection of Privacy Act (FOIPPA)***

I am writing further to your request received by Road Safety BC, Ministry of Justice, (previously Office of the Superintendent of Motor Vehicles). Your request is for:

*The total number of Immediate Roadside Prohibitions issued in the month of June 2014; Copies of every IRP decision from the month of June 2014 in which the prohibition was revoked.*

Immediate Roadside Prohibitions (IRPs) are issued by Municipal Police or RCMP. The total number of IRPs processed by Road Safety BC in the month of May 2014 is 1,802. The number of IRP reviews conducted in the same month by Road Safety BC is 313. The total number of IRPs overturned, as represented by the enclosed records, is 82.

Please find enclosed a copy of the records located in response to your request. Some information has been withheld pursuant to sections 15 (Disclosure harmful to law enforcement) and 22 (Disclosure harmful to personal privacy) of FOIPPA. A complete copy of FOIPPA is available online at:
