


EXECUTIVE ORGANIZATION CHART






Ministry Profile

The Ministry regulates and monitors the liquor industry to protect the public from harm that may be caused by making and selling liquor or products that contain alcohol.


Through the Liquor Distribution Branch, the Ministry is responsible for managing and regulating the importation, distribution and retailing of beverage alcohol in the province.
