I am writing further to your request received by the Ministry of Environment. You narrowed your request on May 10, 2012 through conversation and/or email with John Wilson. Your request is for:

*The final sample results for the samples (Rick Wagner) collected (3). These samples are representative of: the concentration of the chemicals that were present in the storm sewer prior to discharge into Mill Creek, the concentration of the chemicals in Mill Creek once complete mixing with the creek water was observed, and the initial concentration of chemicals in the water along the shoreline of Okanagan Lake near hot sands beach after the spilled material entered the lake.*
