The B.C. government has confirmed it plans to reduce BC Ferries service on both minor and major routes, cut seniors' discounts and test slot machines on board one of its main routes. Transportation Minister Todd Stone announced the cuts and changes on Monday morning. "The first phase is service reductions to lower-use round trip sailings on the minor routes, and on the higher-cost northern routes, accounting for \$14 million in net savings. These service adjustments will be implemented in April 2014," said Stone.

A total of 6,900 sailing per year on 16 minor routes will be affected. Six minor routes will not be affected.

Most of the sailings to be cut were identified as running at roughly 20 per cent capacity or less. These include early morning and weekend sailings, and late night sailings on the weekends, particularly during the non-summer months.

Other changes on the minor routes include combining separate sailing into combined sailings with multiple stops, and introducing a reservation system.

Stone said there would be another round of community consultation this fall before the changes are finalized and rolled out this April. He did not have an estimate of the number of jobs that might be affected.

Future changes to the major routes are also planned, he said.

"BC Ferries will also implement further changes to the major routes prior to April 2016 to achieve \$4.9 million in savings. Minor and northern routes will not be affected by these changes."

The specific details of how any of the major routes will be affected were not announced. Seniors discounts slashed

Dear Madam and Sirs:

I am a resident of Salt Spring Island and have been a supporter of the provincial Liberals for many years. I'm writing this letter to express my outrage at the controversial announcement today by the Minister of Transportation regarding major changes and cuts proposed for the BC Ferry Service commencing April 1, 2014.

It is mind boggling that the government would proceed with a major announcement before completing a series of community engagement meetings planned for a six week period over the next month or so. I can only deduce that the timing must be attributed to inexperience, or incompetence – or perhaps worse, an intended "public relations" strategy. Regardless, it is frankly rude, condescending and offensive to the citizens of this province invited to participate and who represent 20% or more of the total provincial population.

Furthermore, the proposed cuts and changes do little to meet the so-called "fiscal fairness" benchmark that the government so proudly touts as a "value" that will guide its decision making. "Fiscal Fairness is the practice of government that ensures that all taxpaying citizens are treated in an equitable manner."

For example, why were there no changes announced regarding the Interior ferry services? As a reminder, the BCTFA, in cooperation with the MoTI, continues to fund and administer contracts for fourteen ferry routes in the interior of British Columbia which <u>run free to the user</u> as part of their obligation to highway funding. The interior routes include six vessels, five reaction ferries, two aerial tramways (winter use), five cable ferries, plus tugboats and barges, all of which provide services to the customer <u>at no charge</u>. The fleet carries more than 2.4 million passengers and more than 1.5 million vehicles annually without charge to the user at an annual operating cost of \$20.8 million and (Ministry of Finance – Budget Estimates - 2013).

I am also a senior and resent the removal of complimentary personal travel between Monday and Thursday. The strategy is insidious at best since it pits one major demographic against all the others. If anyone at any age can travel free in the Interior, surely seniors over the age of 65 can continue to travel free between Monday and Thursday on the coast! Let's be clear, a walk-on senior passenger costs the ferry nothing. To conclude that it is a significant "cost" that must be cut by half is nonsense.

I can assure you that this will only cause another round of cuts in service (or increase in fares) as a result of a drop in total ridership, which will inevitably occur. Furthermore, the \$6 million so called "senior savings" are a pittance in the overall approximately \$800 million ferry corporation operating budget and can be found easily elsewhere.

The proposed "gambling" venture on various routes is another example of a government afraid to tackle the excessive costs of union wages, collective agreements, defined pension plans and executive pay. Instead, it's easier to go after the "low hanging fruit" like seniors and the vulnerable citizens who might be attracted to "gambling" while travelling on perhaps the most spectacular natural coastal routes in the world. How can the government in all good conscience

promote gambling while at the same time fund programs to mitigate the massive social and economic costs of gambling addiction? It is irresponsible and unconscionable. Finally, I recommend that the government immediately withdraw the proposed changes announced today and proceed with the public engagement meetings as planned. There doesn't seem to be any point in "engaging the public" otherwise, particularly if the government has already made up its mind. The announcement preempts any rational discussion and creates a climate of antagonism and unpleasant confrontation. I can assure you that the process will not be helpful or productive for the government, consultants or the participants. Thank you.

I am a resident of Prince Rupert and have taken BC ferries all of my life. When my grown children were young we went on the ferry every summer from Prince Rupert to Port Hardy. The cost was slightly higher than driving but since my husband often could not go it was the only way for a young mother with s22 children to make the 1000 mile trip to Vancouver. The ferries were always full in the summer and you had to make your reservation early.

In the past few years I have rarely taken the ferry. It has simply been priced out of the market. When we have taken the ferry, it has almost always been when we were going to see a S22

S22in Vancouver. The cost of the ferry is thenS22S22During these trips the number of cars on deck has always been fewerthan 30. And many of the other riders were also takingS22of people and some of the facilities are not operational. Since it costs nearly as much to run theboat empty as full this makes NO SENSE! Lower the cost, fill the boat and make a stab atmaking a profit.

Last summer a friend with a family of three wanted to make a return trip on the ferry from Prince Rupert to Port Hardy and the cost---without a stateroom was \$1863.00!! And once you get to Port Hardy you need a hotel room since the ferry arrives at 10:30 at night. Then you need to spend the next day getting to Vancouver-spending money on gas, food and an additional ferry. Additional costs. Therefore most people in my community either drive or fly. It is the CHEAPER option. The ferry route was intended to be a highway extension, not a holiday destination for wealthy European visitors. Those adds about Ferry Vacations make my teeth grind.

Please think about my remarks. We are already isolated in the north. At times the road is closed for days between Prince and Terrace for a variety of reasons and sometimes the planes don't fly for days at a time. We are then totally isolated. We NEED the northern ferry service and we need it to be a reasonable option not an overpriced cruise line.

As for the slot machines!!!!!! Why does your government want to turn our province into a community of gamblers? Many people who can ill afford to gamble do so. And deleting senior rates makes no sense either. Especially on holiday weekends. Many seniors will travel before or after the holiday thereby decreasing the crush at the ferries. This initiative will only decrease ridership overall and add to the difficulties on the long weekends.

I have written before about the overpriced northern route costs. Have someone look at the history of ridership and you will be able to see that when prices started jumping up, ridership went down. No one can afford to ride it.
