

Re: Lower Kootenay Indian Band vs. Her Majesty the Queen

Enclosed for your convenience is a copy of my letter to you of August 31st, 1983.

We have now been informed that the Office of Native Claims has recommended to the Minister of Indian and Northern Development that the cut-off claim be accepted for negotiation, on the basis that the 2365 acres were promised to the Band in an agreement or treaty made between Indian Reserve Commissioner Vowell, on behalf of the Government of Canada and Chief Alexander on behalf of Lower Kootenay, on or about September 25th, 1908.

We expect the Government of Canada to commence negotiations within the next few months as to quantum for the loss of 2365 acres. The Band is confident that a partial resolution of the claim will be forthcoming in the near future. If British Columbia wishes to join in these negotiations to arrange a full and complete settlement, please advise Manfred Klein at the Office of Native Claims office in Vancouver.

In any event, we will not proceed with the above mentioned action without giving you at least one month's notice in writing. I assume you will take no steps to strike out the action without giving us equivalent notice. If this is not satisfactory, please inform me at your earliest convenience.

RE: LOWER KUTENAI INDIAN BAND

Thank you for your letter of August 22nd, 1983. We shall be serving you in the very near future with a Demand for Discovery of Documents.

At present, our plans, subject to change, are to discontinue the present action with regard to the land cut-off by the McKenna/McBride Commission if a satisfactory settlement can be reached with the Federal Office of Native Claims. We have been corresponding with the Office of Native Claims for some time in relation to the cut-off lands and should be meeting with lawyers from the Department of Justice on September 22nd, at Creston. If that meeting proves fruitful, we may well discontinue the present action entirely and issue a fresh Writ solely for declaration of Aboriginal Title to the traditional tribal territory of the Lower Kutenai Band.

As the Band councillors have recently changed, you may expect a change in the style of cause in any event. We shall contact you after our meeting with Justice and inform you of the course of action we shall pursue.
