Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Advanced Education, Innovation and Technology. You narrowed your request on July 26, 2012, as follows:

- Specific records (as listed in your request) related only to the College and Institute Act, Royal Roads University Act and University Act components of Bill 18 on the following subjects:
  - 1) The development of and amendments to Bill 18, the 2011 Advanced Education Statutes Amendment Act;
  - (2) Any cabinet agenda at which Bill 18 was discussed, including background information submitted to Cabinet;
  - (3) Briefing notes prepared for the Minister of Advanced Education, including Question Period preparation on the subject of Bill 18;
  - (4) Letters sent from the Ministry of Advanced Education to post-secondary stakeholder groups. The time frame is Sept 1, 2011 to June 1, 2012.

Although a thorough search was conducted, no records matching the specific documents you requested were located. However, the ministry has provided the attached May 1993 *Report of the Committee on Governance in Colleges and Institutes* for your information.

As no further clarifications were obtained from you following our August 7, 2012, email communication, your file is now closed.
