BCMA wants ban on MMA for all of Canada

ADVICE AND RECOMMENDED RESPONSE:

- I understand there is discussion within the BC Medical Association to support a ban on mixed martial arts in Canada.
- Mixed martial arts is one of many full-contact sports in which athletes can suffer serious injuries.
- It is a growing sport with a large fan base throughout Canada, including here in British Columbia.
- Mixed martial arts is regulated in B.C. by athletic commissions at the city or community level, not by the Province.

KEY FACTS REGARDING THE ISSUE:

- On Aug. 13, 2010, media reported on a proposed resolution the BC Medical Association is working on that will call for a national ban on mixed martial arts (MMA).
- The resolution is scheduled to be submitted by the BCMA to the Canadian Medical Association during its AGM, which is being held in Ontario from Aug. 23-25.
- One day after the BCMA announced it would submit their resolution to the CMA, the province of Ontario announced it would allow the sanctioning of MMA events beginning in 2011.
- Since the BCMA's intentions were publicly announced, many editorials have criticized the organization for moving forward with its resolution.
 - A Vancouver doctor told media the BCMA's call for an MMA ban is wellintentioned, but the emergency room physician, who has worked ringside, questioned whether the medical association understands the sport;
 - o An editorial in the Province newspaper and on Radio NL both expressed views against the BCMA.
- The City of Vancouver hosted its first Ultimate Fighting Championship (UFC) event on June 12, 2010.
- For more than 20 years, the Province has received occasional requests to establish an athletic commission to regulate professional combative events.
 - o A recent request came in the form of a 2008 UBCM resolution, initiated by the

- City of Vancouver. A March 26/08 media report states Vancouver city council voted to ask the Province to be the sanctioning body of mixed martial arts competitive fighting events.
- o On Aug. 26/09, the attorney general met with UFC officials, who later met with the Vancouver Athletic Commission and planned to contact federal officials.
- The Province's consistent response

has been that such regulation is best administered at the local level so local needs are considered. Provisions are, therefore, contained in the Community Charter and the Vancouver Charter to permit municipalities to establish athletic commissions if they choose.

- Regulation of professional combative contests is primarily focused on the legality of proposed events (licensing and event scrutiny) and the safety of fighters.
- Proposed amendments to s. 83 of the Criminal Code were introduced on May 15/09. but were not passed before the prorogue of Parliament. Bill C-31 would have expanded the list of permitted sports covered under current prize-fighting provisions. Amendments also allowed a province to decide whether to expand the list of sports permitted to take place within that province and authorize specific contests.
- Under Criminal Code s. 83, participants in a "prize fight" commit a summary conviction offence.
- An exemption is made for boxing contests involving amateur athletes wearing boxing gloves or boxing contests held with the permission or under the authority of an athletic board or commission established by or under the provincial legislative authority.

Initially marketed as "extreme fighting" with few rules, mixed martial arts attracted a reputation for violence and an underworld following. Now highly regulated in the U.S., it is sanctioned in over 40 states.

Sorry for the delay in replying.

Municipalities, including the City of Vancouver, have the authority to deal with athletic contests (e.g. boxing; wrestling; mixed martial arts) in a number of different ways -- for example, they can:

- regulate businesses -- e.g. require a sporting event to have an event permit;
 require a martial arts school to hold a business licence; set rules in
 relation to the conduct of a business
- prohibit operation of a public show or exhibition of a particular type or in a particular location
- prohibit professional boxing, professional wrestling and other professional athletic contests

In relation to the regulation of professional athletic contests, a municipality may delegate its authority to an athletic commission, in which case it can authorize the commission to make rules regulating professional boxing, wrestling and similar activities, including imposing fines and seeking injunctions.

You may have read in the Now newspaper recently about the amateur MMA event coming to the Red Robinson April 23rd.

Our City Athletic Commission regulates only professional boxing.

We created our commission under the authority of Section 143 of the Community Charter and more specifically created our bylaw regulating professional boxing under the same authority.

Amateur MMA we don't believe falls into the intent of the Community Charter judging by the wording of it which reads as follows:

Municipal Commissions

- 2 If a Council adopts a bylaw under this section to establish an athletic commission consisting of at least 3 members, in addition to any delegation under section 154 (delegation of council authority), the council may, by bylaw, do one or more of the following:
- a) authorize the commission to make rules regulating professional boxing, wrestling, and similar activities, contests and exhibitions.

My question re intent is this: does this mean we can regulate only professional events? Is this the intent of the legislation? Or would it also include amateur events as well?
