In particular – Vicki Huntington asked Minister Wat about BC's actions to ensure Alberta lives up to its obligations under TILMA/NWPTA with respect to residence requirements for companies wanting to work in Alberta's oil and gas industry. Huntington mentioned that Alberta's residency requirements have led to residency audits on at least 17 BC companies, and that one constituent of hers was forced to move his company and family to Alberta. V. Huntington: Oh, I thank the hon. member.

The government's campaign platform included a promise that B.C. will ensure Alberta lives up to its TILMA obligations not to discriminate against B.C.-based companies that want access to Alberta's oil and gas play. I can't tell the government how pleased I was to see my previous questions on this subject had made it into your platform.

Even so, it was a curious election promise, because just before the election the former Minister of Jobs told the House that the trade dispute had been resolved. I will get back to you on the name of the company, but I would like to say that my ministry along with the Oil and Gas Commission is working to conclude the mutual recognition agreement with Alberta that is in B.C.'s best interest.
