*Any and all emails, memos, briefing notes, correspondence, reports or other documentation, excluding news clippings or news releases and public commentary/correspondence to the Deputy Minister, John Dyble, or the head of the public service, Office of the Premier, and the Deputy Minister of Health, regarding the investigation into possible privacy breaches and related suspensions and terminations in the Ministry of Health sent or received by the Deputy Minister and head of the Public Service John Dyble, sent or received by the Office the Premier, and exchanged between the Deputy Minister to the Premier and Head of the Public Service and Deputy Minister of Health. Time frame is May 1, 2012 to July 23, 2014.*
