#### KFY MESSAGES

1. Northern Health Authority (NHA) does not have technical expertise to provide input into the environmental assessment (EA) for LNG facilities and pipelines

- 2. NHA would like Ministry of Health (MoH) to provide this expertise
- 3. MoH is not organized to do this currently, does not have a mandate to do this, but agrees that input into EAs for LNG should be at a provincial-level
- 4. However, there is attention being paid to such issues: for example, Health Authorities and MoH work closely with Ministry of Environment (MoE) on big issues such as Rio Tinto Alcan Air Quality and Selenium related to coal mining in the Southeast. MoE also has responsibility for standards for air quality.
- 5. Tim will take the need for participation from the provincial health experts on EA to the Deputy Minister. This will take at least a couple of months for an approach to be developed.
- a. While this is being worked out, we can all rely on the current relationship between MoE, NHA and MoH to ensure there is a place for issues to be raised and discussed
- b. Ultimately manpower and expertise are required for a full response from MoH
- 6. David referenced work that NHA is doing related to work camps in the north there is an interest in understanding how these camps impact health services and other potential impacts. The work is early in development, but there is likely a linkage to the EA in this regard.

#### ACTION ITEMS

**ISSUE:** Rio Tinto Alcan's (RTA) Kitimat smelter modernization project: EMA permit amendment to increase SO<sub>2</sub> emissions – public consultation phase.

### **BACKGROUND:**

RTA's total air emissions footprint will be reduced by approximately 50 per cent after smelter modernization is completed in 2014. However, increased aluminum production and increasing sulphur content in coke will result in an increase in SO<sub>2</sub> emissions. RTA is therefore applying for an increase in to the permitted SO<sub>2</sub> emission limit from 27 tonne/day to 42.

For this complex *Environmental Management Act* (EMA) application, RTA has assembled a multi-disciplinary team to assess four lines of impact assessment evidence (soil and water acidification, human health and vegetation). In 2012, RTA undertook extensive field studies to collect data in support of the application. They have now produced a draft technical assessment report (TAR) in which two lines of evidence are ranked "low" for risk, and two are ranked "moderate" for risk. Consistent with a 2007 Memorandum of Understanding on SO<sub>2</sub> management between Ministry of Environment (MOE) and RTA, an adaptive management approach is being taken to verify and address the risks over a period of years.

Throughout the modernization project and EMA permit amendment process, RTA has successfully engaged in deep consultation with the Haisla First Nation.

Just to add to what Nathalie sent below. This workshop is a follow-up to the amendment to Rio Tinto Alcan's SO2 permit limit, and is further to the subject that you were involved with in the spring this year regarding referral correspondence with Ben Weinstein. The permit amendment was issued by our program (Ian Sharpe as decision-maker) dated April 23, 2013 increasing RTA's SO2 emission limit from 27 t/day to 42 t/day. One of the clauses contained in the amendment is for RTA to develop and implement an Environmental Effects Monitoring (EEM) Plan that includes the requirement to establish impact threshold criteria along four lines of evidence, of which human health is one. There is a workshop scheduled for mid-August to address the EEM plan regarding the three non-health-related lines of evidence (vegetation, soil acidification, water acidification), with the health line of evidence being scheduled for a separate workshop (tentatively September 10<sup>th</sup> or 11<sup>th</sup> in Vancouver).
