Do I need to fill out the “e-Bidding Registration and Change of Information Form”?

20. The Province may amend this Agreement at any time by providing notice to the Bidder of the amended Agreement. Continued use of the Service after such notice constitutes the Bidder's acceptance of the amended Agreement.
21. With the exception of information requested by the Province, any changes to the Form or these terms and conditions made by the Bidder are as if not written.
22. These terms and conditions are governed by and are to be construed in accordance with the laws of British Columbia.
