I am writing further to your request received by the Ministry of Justice (Road Safety BC). Your request is for:

“Copies of all communications, correspondence, internal memorandums, email messages, letters, telephone call logs and other documentation between the Port Mann RCMP and Constable Paula Penney or Corporal Nanton and RoadSafetyBC/OSMV, including adjudicators, team leads, managers of adjudication and any other staff members or police liaison at RoadSafetyBC/OSMV; In particular, copies of communications listed above regarding approved screening devices in the detachment, dry gas alcohol standards used to calibrate approved screening devices, an audit of Port Mann RCMP approved screening devices, and/or Certificates of Qualified ASD Calibrators. The time period is June 30, 2014 to July 31, 2014”
