Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Justice and Attorney General Your request is for:

"All departmental records from BC Corrections regarding violent incidents against correctional officers and between inmates from January 1, 2012 to August 1, 2013 including but not limited to email, memos, reports and audits."

You narrowed your request on August 16, 2013 through conversation and email with Alan Hughes to:

"Statistical data on records from BC Corrections regarding violent incidents against correctional officers and between inmates from January 2012 to August 1 2013."

Please find the following information located in response to your request.

- Between January 01 2012 and July 31 2013, there were 274 violent incidents against staff in B.C.
 Correctional Centres. This is an average of 0.5 violent incidents against staff per day. There are approximately 1500 staff members working in correctional centres.
- Between January 01 2012 and July 31 2013, there were 1,463 violent incidents between inmates in B.C. Correctional Centres. This is an average of 2.7 violent incidents between inmates per day. On any given day there are approximately 2500 inmates in 9 provincial correctional centres.

Please note that correctional staff is trained to record all incidences of violence which can range from threatening statements to physical assaults. BC Corrections' Management Services Policy Manual defines violence as:

"Any planned act, or expression of intent to plan an act, to inflict physical or other harm against a person or a workplace, including verbal harassment, or damage to personal or public property. A threat can be spoken, written or symbolic."

It is important to keep in mind that many incarcerated individuals have violent criminal histories and that approximately 56% suffer from substance use and/or mental illness disorders which can lead to unpredictable behaviour.

Your file is now closed.

These records will be published on the BC Government's Open Information website a minimum of 72 hours after it is released electronically or a minimum of five business days after it has been released by mail in hardcopy.
